6. Lessee shall not breed or flush this animal without written consent of the Lessor.
7. Lessor may at any time break this lease and recover the animal if he/she feels that the animal is in danger, defaults in insurance payments, or is not getting the required care.
8. The subject animal will remain on the Lessee's current listed address above and may not be moved to any other lot or location without the Lessor's permission.
9. If this lease is broken due to default of any of the terms listed above, the Lessee will have 10 days to return the animal and original registration paper to the Lessor.
10. Amendments and alterations to this lease shall be in writing and shall be signed by both parties.
